In New Jersey, an action for personal injury or wrongful death generally must be brought within **2 YEARS...** yes, within two years from the date when the cause of action occurred.

A wrongful death action accrues on the date of death. Immediate action in contacting an experienced attorney such as Roy Macaluso, Esq., must be taken immediately to see that our Laws DO Work for YOU!

### **What damages can I recover?**

The Laws of Personal Injury include entitlements to recover for actual damages, wrongful conduct, losses such as costs of reasonable and necessary medical care, property damage, car rental expenses, costs of domestic services, and loss of earnings.

The law is able to give you compensation for future medical and care expenses. You may also be entitled to non-economic damages such as for physical pain and suffering, mental and emotional suffering, physical impairment, inconvenience, disfigurement, loss of enjoyment of life, loss of consortium (disruption of your personal relationship with your spouse), etc.

### **How can I determine how much my claim is worth?**

Attorneys are prohibited from promising a client that they will obtain a certain amount of money. A claim is value based upon estimates of what a jury believes the case to be worth.

Sometimes there will be considerable compensation for injuries if they are found to be severe with extensive medical treatment, that includes absences from work or serious permanent injuries, especially if you were a healthy young worker, prior to the accident, then your compensation possibly increases.
